

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to caaidental.com Center for Advanced Aesthetic & Implant Dentistry (CAAID) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to CAAID include cuttingedgeperiodontist.com and CAAID. The CAAID website is an information and services site. By using the CAAID website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site and to contact you for appointment information, CAAID may collect personally identifiable information, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) sending us an email message; (d) submitting your credit card or other payment information when ordering and purchasing products and services on our Site if available. Use of your Personal Information

Sharing Information with Third Parties

CAAID may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to CAAID, and they are required to maintain the confidentiality of your information.

CAAID may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on CAAID or the site; (b) protect and defend the rights or property of CAAID; and/or (c) act under exigent circumstances to protect the personal safety of users of CAAID, or the public.

Tracking User Behavior

CAAID may keep track of the websites and pages our users visit within CAAID, in order to determine what CAAID services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by CAAID. Use of Cookies
